#### **EDITORIAL**

While many have been enjoying another long hot summer with a good book or some beach-going, spare a thought for those who have curtailed their holiday activities to work on submissions for the Government's Education Amendment Act. The Bill, if passed, will introduce partnership schools into our education system, mirroring similar approaches in the United States where private sector investors have set up schools in low-decile areas in an effort to jump start achievement. While the Unit commends an attempt to address education inequality, we also have some concern around the proposed framework: schools would be run by a private Ministry of Educationapproved sponsor, they would not have to hire registered teachers, teach to the national curriculum, or run a Board of Trustees; and there is little structure specified around the soliciting of students (which has the potential, as in the USA, to leave local public schools vulnerable while their best students are 'cherry-picked').

The cynical amongst us would also question why the Government chose late January as a time to hear feedback on the Bill, while most Kiwis are still in holiday mode. The attempt to hustle through legislation that will impact the children most struggling in our current education system is somewhat frightening, and the lack of detail in the Bill itself reflects this hasty approach. Testing what is essentially an ideological experiment without proven results on the children who will direct the future of our nation is unacceptable. Promoting an approach which could negatively affect local schools and communities is objectionable. Undermining our registered teachers and

national curriculum by allowing partnership schools to disregard them is intolerable. And creating a new system without addressing the social inequalities contributing to our current problems is negligent.

The Social Policy and Parliamentary Unit has formulated a submission on the Bill (which can be viewed on our website) and we would hope that other organisations have also chosen to speak out on this legislation. We cannot allow education policy to be treated lightly, and we cannot entertain a 'holiday' mentality with public policy—tuning out on issues that affect our young people and the New Zealand we are shaping.
