## EDITORIAL

When the Alcohol Reform Bill finally passes into law it will be interesting to see what actually gets reformed—if anything at all. And it will also show whether Parliament is keeping in step with public opinion around this thorny issue. New Zealand has a long and troubled history around binge drinking, and the politics of alcohol law reform has made careers—and ruined many others—so it’s understandable MPs are reticent making a stand on this issue.

The Bill is currently at select committee stage but sits 45th on Parliament’s order of business, so it could be August or September before it is passed. The Prime Minister has recently stated that he thinks any changes to pricing will have little impact on drinking habits.

Early indications from MPs show that there are a number on both sides of the House who are leaning towards a vote to keep the purchasing age at 18. But on the other hand, the general public seem quite comfortable with legislation making it harder for people to access alcohol, particularly youth.

A recent poll in the New Zealand Herald shows at least 80 per cent want some form of increase to the purchasing age. Research is coming to light showing the pricing of alcohol does in fact alter people’s habits.

But of all the damning statistics and terrible stories about the problems of liquor, one of the most alarming things to recently emerge came from Principal Youth Court Judge Andrew Becroft. He is quoted saying the real purchasing age is now ‘about 14 or so’.

Judge Becroft is clearly a man with his finger on the pulse and the consequences of this scenario are obviously dire.

The Unit is currently in the process of writing to every MP asking them to consider increasing the age of purchase at

### Continuing to speak out about the Green Paper...

UNICEF New Zealand has compiled over 80 submissions made to the Government's Green Paper for Vulnerable Children by various NGOs and community groups. UNICEF New Zealand has compiled a briefing paper for the Government summarising these submissions and putting forward recommendations for the upcoming Children's Action Plan.

The Salvation Army Social Policy and Parliamentary Unit is now a party to this collaboration and we added our own Green Paper submission and endorsement to this process. A final briefing paper will be released later in July 2012.

We continue to call for transparency, public debate and true consultation with NGOs and community groups as these Children's Action Plans are developed.
